1. All prices must be quoted in Ringgit Malaysia (RM) and payment either **Cash** or if **Bank Draft / Money Order** of **RM 500.00** for each vehicle tendered as deposit make payable to **PELABUHAN TANJUNG PELEPAS SDN BHD** will be required to be attached with this Offer Form. Please ensure that you receive an official **Acknowledgement of Submission** before depositing the completed tender into the (Tender Box No. 3). Further claim or inquiry after submission without an official acknowledgement from Pelabuhan Tanjung Pelepas ("PTP") shall not be entertained.
2. Offer shall remain valid and open for acceptance for a period of 90 days from the closing date. The closing date will be on **Wednesday, 12 October 2011** at **12.00 p.m.**
3. Successful bidder shall arrange for full settlement either in cash or if bank draft make payable to **PELABUHAN TANJUNG PELEPAS SDN. BHD.**
4. All cost incurred for documentations at JPJ for the transfer of ownership of vehicle(s) will be borne by the successful bidder.
5. PTP shall advise the amount of customs duty and tax which shall be paid through PTP.
6. The successful bidder will also have to purchase the spare parts as part of this tender package either in full or proportion based on the number of vehicle/s awarded. The price list of the spare parts is attached with the Offer Form.
