- Safeguarding company employees, commercial and operational assets and our client's interests
- Intolerance of the conditions and behaviors that contribute to breaches of security
- Promote security awareness amongst all employees
- Communicate relevant content of the policy, where applicable to third party organizations, visitors and contractors
- Recording and communicating security performance throughout the organization

The Management will visibly uphold the principles of this policy and integrate them throughout the company and will regularly review security management performance.

Every employee whose work may create a significant security impact will be trained and held accountable for complying with the policy and related procedures, practices, instructions and rules.

POLISI SEKURITI (KESELAMATAN)

Pelabuhan Tanjung Pelepas bertekad menyediakan kawasan tempat kerja yang selamat dalam menjalankan operasi perniagaan melalui pematuhan undang-undang tempatan dan antarabangsa serta Kod ISPS.

Polisi ini diwujudkan dengan mengambil kira keprihatinan terhadap keselamatan kakitangan, pelanggan dan aset syarikat bagi menjamin kejayaan dan pertumbuhan perniagaan syarikat pada masa akan datang.

Objektif:

- Menambahbaikkan proses dan prestasi keselamatan secara berterusan melalui aktiviti audit yang berkala
- Mengenal pasti dan menilai semua isu-isu berkaitan keselamatan dan mewujudkan langkah kawalan bagi mengurus dan mengurangkan risiko keselamatan ke tahap yang boleh diterima

- Mengguna pakai mana-mana inisiatif keselamatan mengikut kesesuaian operasi dan komersil sekiranya perlu
- Melindungi kakitangan, perniagaan dan harta-benda syarikat serta kepentingan pelanggan
- Tidak bertolak ansur terhadap keadaan dan perilaku yang menyumbang kepada pelanggaran terhadap peraturan keselamatan
- Mempromosi kesedaran keselamatan kepada semua kakitangan syarikat
- Menyampaikan kandungan polisi yang berkaitan dan bersesuaian kepada pihak ketiga, pelawat dan kontraktor
- Merekod dan memaklumkan prestasi keselamatan kepada seluruh organisasi

Pihak Pengurusan secara nyata mendukung prinsip dan mengintegrasikan polisi ini terhadap keseluruhan organisasi serta menyemak prestasi pengurusan keselamatan secara berterusan.
