
Reminder

PTP Bus Service

PTP bus service is provided at the front of each yard block on the shore side of the terminal wharf. These buses pick up terminal staff / passengers and stop at the Port Utility Building (PUB). PUB is the amenities are for the terminal staff as well as vessel crew.

PPE Free Area



WHAT ARE THE HAZARDS IN PTP?

Wharf Area:

Loading & Unloading heavy loads under quay cranes | Moving prime movers | heavy equipment and vehicles | Falling into the sea | Falling objects | Slip and trip over uneven surface e.g. quay crane rails, uneven road surface | fall due to broken gratings | Smoke emission | High noise level.

Yard Area:

Moving Rubber Tyre Gantry crane (R.T.G.) Falling container during Loading & Unloading of container operations tripping over container bays Leaking dangerous goods Moving prime movers heavy equipment and vehicles.

Onboard Vessels:

Falling overboard | Slippery deck conditions | Hatch openings | Flammable gases | Tripping over objects | Falling Objects | Loading & Unloading heavy loads under quay cranes | Narrow walkway | Rusty railings or defective structures.

Work Sites:

Flammable condition | Falling objects | Slippery floor | Bad housekeeping | Faulty tools & machinery | Electrocution | High Noise Level | Moving machinery | heavy equipment and vehicles.







Always give way to the movement of Container Handling Equipment.



Pay attention to audible and visual alarms and warnings.



Always use the pedestrian walkways while crossing the roads.



Always use the terminal bus to travel from quay side to the terminal public utility building. And back again.



Always wait for the bus inside the appointed bus stops, safely away from the roadside.



Always ensure to return to your vessel well before the ETD.



DON'Ts

Do not leave the vessel without wearing your Personal Protective Equipment (PPE). Consists of Safety Helmet, Safety Vest & Safety Shoes.



Do not stand or walk under a suspended load.



Do not walk through the container yard. It is declared as a high risk work area and no walking zone.



Do not enter prohibited areas.



No smoking except at designated smoking areas.



Do not litter inside the terminal.



Do not delay your vessel departure by returning late from shore.



Drugs & Alcohol are prohibited in the PTP worksites
