IMPLEMENTATION OF DANGEROUS GOODS SURVEILLANCE CHARGE AT PORT OF TANJUNG PELEPAS

With reference to the recent announcement by the Johor Port Authority through Port Notice No 05/2023 with Reference No LPJ/IP/OPS24JLD3(93) dated 30 August 2023 as enclosed.

We would like to inform you that there will be an implementation of a Dangerous Goods Surveillance Charge. This charge will be applicable to all status of containers at the Port of Tanjung Pelepas, effective from **1 October 2023**.

The charge and method of calculation are as follows:

RM 15.00 per container per 24 hours or part thereof. The charge will be applicable based on the container category and specific activities.

Container Category	Start Date	End Date
Transshipment	Container discharged from the vessel	Container loaded onto the vessel
Import	Container discharged from the vessel	Container gate out (via road or rail) from the terminal or to the designated terminal free zone area
Export	Container gate in (via road or rail) into the terminal or from the designated terminal free zone area	Container loaded onto the vessel
