**IMPLEMENTATION DATE FOR PORT OF TANJUNG PELEPAS REVISED PORT TARIFF
– JOHOR PORT AUTHORITY (TANJUNG PELEPAS PORT) (SCALE OF RATES, DUES
AND CHARGES) (AMENDMENT) BY-LAWS 2021 [P.U.(A) 355/2021]**

This notice is to advise you that through the Federal Government Gazette, the Johor Port Authority (Tanjung Pelepas Port) (Scale of Rates, Dues and Charges) (Amendment) By-Laws 2021 [P.U.(A) 355/2021] has been gazetted on 8 September 2021 and shall be in force commencing 9 September 2021.

As a reference to the mentioned subject, we would like to inform you that the revised port tariff implementation date for Port of Tanjung Pelepas shall be effective on **1 October 2021**. Nonetheless, the existing scale and rate of charges as contained in the Johor Port Authority (Tanjung Pelepas) (Scale of Rates, Dues and Charges) (Amendment) By-Laws 2019 [P.U.(A) 306] shall continue to apply until **30 September 2021**.


Notwithstanding the aforesaid, the By-Laws Johor Port Authority (Tanjung Pelepas) (Scale of Rates, Dues and Charges) (Amendment) By-Laws 2021 [P.U.(A) 355/2021] shall be read in conjunction with the Johor Port Authority (Tanjung Pelepas) (Scale of Rates, Dues and Charges) (Amendment) By-Laws 2019 [P.U.(A) 306].

In addition to the above and pursuant to section 16 (4) of the Port Authorities Act 1963 (Act 488), we also hereby inform that the charges for the Inter Terminal Transfer (ITT) at Port of Tanjung Pelepas as described in the attachment shall be implemented on **1 October 2021**.
