

Requirements on DG Cargo Declaration

 WISMA PTP BLOCK A
 PTP

1. All shipment of Dangerous Goods (DG) cargo under category import, export and transhipment require declaration before entering PTP Terminal.
2. Declaration shall be made no later than 48 hours prior to vessel arrival/container gate in.
3. **Declaration does not guarantee acceptance.** It is advisable to perform an early declaration due to possibility of the following:
 - i. DG not allowed to enter port limit
 - ii. DG not allowed for any handling or storage
 - iii. Conditional acceptance - imposition of other regulatory requirements that must be complied with prior to accepting the DG into PTP
4. Declaration shall include the following:
 - i. IMDG Class and UN Number
 - ii. Safety Data Sheet (SDS)
 - iii. DG manifest / Cargo Packing Certificate - *if available or deemed necessary to facilitate approval*
 - iv. Container number - *not required for pre-booking*
 - v. Volume or weight - *if available or deemed necessary to facilitate approval*
5. Declaration shall be made via email to:

Section 42, Johore Port Authority (Tanjung Pelepas) by-Laws 2000 stated that the handling of dangerous goods shall have written permission from Port Authority and/or the licensed operator (Port of Tanjung Pelepas Sdn. Bhd.).

JPA Group	Acceptance Details
JPA Group 1 (High Risk)	<ul style="list-style-type: none">▪ Vessel carrying JPA Group 1 cargo is not allowed to berth in PTP, except with written permission from both PTP and Johor Port Authority.▪ Discharge, storage, loading or any types of handling is not allowed in PTP port limit.
JPA Group 2 (Medium Risk)	<ul style="list-style-type: none">▪ Only permitted for direct loading (export), direct discharge (import) and vessel-to-vessel transit within 24 hours period.▪ Not allowed for storage in PTP, except with written permission from Johor Port Authority or PTP.▪ Requirements from the relevant authorities must be complied with.
JPA Group 3 (Low risk)	<ul style="list-style-type: none">▪ Allowed for storage in PTP, subject to availability of storage space.▪ Requirements from the relevant authorities must be complied with.

Johor Port Authority (JPA) By-Law 2000

1. Fine not exceeding one thousand ringgit (RM1,000.00) and in case of the continuing offence shall be liable to a daily fine of two hundred and fifty ringgit (RM250.00) for each day. If the breach continues, shall be liable to the Authority in respect of any loss, injury or damage occasioned to it by such contravention.

*subject to the decision by Authority

Strategic Trade Act (STA) 2010

1. With Intent

- Resulting in Death: Death sentence; or Imprisonment: natural life; (body corporate: \geq RM30 million)
- Other Case: Imprisonment: \geq 10 years; or Fine: \geq RM10 million; or both; (body corporate: \geq RM20 million)

2. Without Intent:

- Imprisonment: \geq 5 years; or Fine: \geq RM5 million; or both; (body corporate: \geq RM10 million)
