

- High visibility vest of fluorescent:
  - Yellow
  - Red
  - Orange
  - Green
- Two bands of reflective material encircling the torso.
- Reflective material at least 50mm wide.

## GENERAL SAFETY FOR TERMINAL USER




Maximum speed in container yard and wharf area



Maximum speed within terminal road and Free zone area



Enter the terminal with valid body pass only




Use shuttle bus to travel inside the terminal area



Use the pedestrian crossing



Safety helmet, high visibility vest and safety shoes is mandatory in operation area



Wear life jacket when working 2 meters from wharf edge




Work with approved Job Permit / Permit-To-Work only



Wear safety harness when working over 2 meters



Place beacon light on vehicle when driving in terminal



Always switch on vehicle headlights while driving



Keep a safe distance while driving



Always give way for pedestrian to cross the road



Beware of moving vehicles



Do not work under suspended load



Do not take pictures or videos inside the terminal area



Do not walk through the container yard



Prohibited to bring in or under the influence of alcohol or drugs in any area of PTP
